# NEW ENGLAND SECTION of the AMERICAN UROLOGICAL ASSOCIATION

## Highlights of the BOARD OF DIRECTORS MEETING, March 15, 2003

### Report of the President

Dr. Sant welcomed Dr. Brendan M. Fox, Section designee for President-Elect of the American Urological Association in 2003 and an ex-officio member of the Board of Directors. Dr. Sant reported that Dr. Arthur Smith of New York had accepted his invitation to serve as the 2003 Leadbetter Lecturer, and Dr. Raja Khauli of Lebanon will be a guest speaker.

Discussion regarding the proposed Resident Travel Grants, offered for the first time in 2003, resulted in the need for a distribution plan, and a committee was organized to formalize application criteria and guidelines.

### Report of the Secretary

Current membership statistics: 344 Active, 177 Senior, 45 Associate, 2 Honorary, 13 Affiliate and 57 Candidate members for a total of 638 members. Requests for transfer into the New England Section:

Dr. Loughlin reported on several initiatives taken to enhance the benefits of membership in the New England Section. The first was the expansion of the Section Newsletter from 2 to 4 issues. The two additional issues will focus on practice-based articles rather than on Section news, and all newsletters will contain a calendar of upcoming urologic events and meetings, as well as job listings.

Dr. Loughlin reported on the 2003 Town Meetings, yet another way that the Section provided value to the members. Holding these meetings within each state allows the organizers to tailor the meeting to matters of local interest. Following each Town Meeting, attendees have been e-mailed a survey asking them to rate the program, the speaker, and give their opinion of the Town Meeting initiative and recommendations for future topics. The January 21<sup>st</sup> Town Meeting held in Newton had been very well received.

The Section has secured a \$20,000 grant from Bayer Corporation for the publication of the New England Section history and the publication parameters will be revised to produce the history within this budget. Board members congratulated Dr. Loughlin on his efforts and thanked Historian Dr. Peter Albertsen for his offer of assistance to Dr. Loughlin.

### Report of the Treasurer

Total assets of the Section were recorded at \$667,341. On the Income Statement, receipts for the year totaled \$389,731, versus disbursements of \$266,797, for a net surplus of \$122,934.

### Reports of Representatives to the AUA

#### AUA Audio Visual Committee

There was a significant increase in the number of audio-visual abstracts submitted for consideration at the AUA Annual Meeting.

#### AUA Board of Directors

Dr. Roth summarized highlights of the Board's February 2003 meeting including the new AUA Building and the benefits that members would receive from the increased space and efficiency of the new facility. He reported that the AUA's Socioeconomic program remained strong, and that AUA legal staff was monitoring a number of ongoing issues such as the Young Antitrust claim against the ACGME, as well as the TAP Pharmaceuticals investigation. The AUA has begun to explore its relationship with AFUD, as concerns had been raised that AFUD was not providing sufficient feedback to the AUA given its participation.

#### AUA By-Laws Committee

Dr. David Green summarized recommended changes to the AUA By-Laws. The "stately minuet" rotation of officers being chosen by the Sections had finally been codified in the By-Laws, and the most significant change involved provisions that had been enacted to prevent floor presentation of a rogue candidate at the AUA Annual Business Meeting. The AUA Nominating Committee will now have the advance authority to accept or reject the officer nominee from the Section, and that nominee will be presented as part of the Nominating Committee's report when presented for ratification at the AUA's Annual Business Meeting.

#### AUA Journal of Urology Editorial Board

Dr. Loughlin indicated a continuing decrease in lag time between submission of a manuscript to the Journal of Urology and disposition, as well as between acceptance and publication. He also indicated that the blinded review issue was effectively dead, as both the Journal Editor and the AUA President believe that unblinded manuscripts are the better format.

#### AUA Investment Committee

Dr. Eyre indicated that the AUA employee retirement fund accounts were now fully divested and under separate management, that the jury was still out on the performance of the new investment company, and that the AUA was continuing to look at various methods of diversification.

### Section Committee Reports

#### Long Range Planning Committee

The Committee recommended the appointment of an ad hoc Investment Review Committee to establish investment guidelines for the Section and to create an educational endowment fund to support residency programs and the educational activities of the membership. The Committee was subsequently asked to make specific recommendations with regard to potential uses of Section funds in enhancing the educational mission of the Section.

### Residents Research Committee

The Committee submitted a set of recommendations for administering the Scientific Research Awards which would be offered by the Section and which had been made possible by a grant from Yamanouchi. The Board agreed that the research funds should not be exclusively available to young academic researchers and that the Section should consider a practicing urologist award as well.

### Local Arrangements Committee

The Section is planning to hold the Board/Past Presidents' Dinner offsite at a restaurant in Mont Tremblant and is investigating various venues for the Friday evening Attendee Reception.

### Scientific Program Committee

Dr. Roth noted that the 2002 Annual Meeting had been one of the Section's finest programs in years and that great effort should be made to keep up the standard for coming meetings.

### Socioeconomics Committee

Board members reviewed a series of emails between Dr. Jeffrey Dann, Chair of the Socioeconomics Committee, Dr. Sant and Dr. Ralph Blair of Harvard Pilgrim Health Care regarding an article in Boston magazine regarding outcomes of radical prostatectomy surgeries at Johns Hopkins Hospital in Baltimore. It was agreed that a response to the article was warranted and the Section will ask the AUA to review the issue, particularly as the AUA had a stated goal of working toward an educated patient population. Dr. Sant will work with Drs. Green and Roth in preparing a letter to present to the AUA.

### Recommendations to AUA Residents Committee

The Section had been asked by the AUA to name a representative and an alternate to the newly established AUA Residents Committee. It was agreed that the offer will be communicated to all Program Directors in the Section so that they could recommend potential residents; Dr. Sant and Dr. Martyn Vickers will then confer to make final recommendations.
